Applications are invited from the eligible APST Meritorious Sports Persons for recruitment of 1 (One) post of Lower Division Clerk (LDC) in the Pay Matrix Level-4 of Rs.25500-81100/- p.m. under Sports Quota in the Directorate of Higher & Technical Education, Govt. of Arunachal Pradesh ,Itanagar.

- i) Name of Post: - Lower Divisional Clerk (LDC).
- ii) Number of Post: - 1 (One).
- iii) **Educational and other qualifications:**
  - (a) Class XII Pass (Passed Class XII from a recognized Board or Institution).
  - (b) Minimum 6 (six) months Diploma course in Computer application from a Recognized Board / Institution.
- iv) **Age limit:** The candidates should not be more than 32 years and not less than 18 years of age as on 31.07.2022 (*Relaxation of upper age limit for APST Meritorious Sportsmen is given to a maximum of 10 years*).

1. Certificate of representation has to be awarded by Secretary of the National Federation of the game concerned for the International level/by the Secretary of the National Federation or Secretary of the State Association of the game concerned for the National level/by Dean of Sports or the other officer in overall charge of sports of the University concerned for Inter- University Tournaments / by Director or Addl. or Joint or Dy. Director in overall charge of Sports or Games for schools in the Directorate of Physical Efficiency in the Ministry of Education & Social Welfare , GOI for Physical Efficiency Drive.
2. Application incomplete or unsigned in any respect or received after the last date will be summarily rejected.
3. The Department will not be held responsible for any postal or other reasons of delay what so ever may be.
4. Candidates already in service may apply through his/her Head of Department/office.
5. Request for correction/furnishing of additional documents etc. after formal receipt of application shall not be entertained at later stage.
6. The application in prescribed form can either be sent in an envelope super scribed " **APPLICATION FOR THE POST OF LDC UNDER SPORTS QUOTA** " by post or directly submitted by hand at Directorate of Higher & Technical Education, Itanagar, Govt. of Arunachal Pradesh, Itanagar up to **31/07/2022 till 1400 hrs. in the application drop box.**

vii) **SELECTION PROCEDURE:** -

- a. **Scrutiny of Documents:** -The shortlisted candidates whose application /documents are found in order in all respects and call letters issued shall have to produce original documents for verification& authentication on date & venue intimated in the call letter. (The Candidates failing to produce original and authentic documents during scrutiny shall be summarily rejected).
- b. **Merit List:** -There will be no written examination as per Govt. guideline. However, the final selection will be done as per priorities /preference prevailing currently in guidelines.

- c. **Medical Examination and character & Antecedent Verification:** -Appointment of selected candidate shall be subject to submission of medical Fitness Certificate and satisfactory verification of character & Antecedent.

- Sports persons who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.
