Sir,

Nominations are invited from your state for admission to 4-year degree course of **B.Tech. (Agricultural Engineering)** for the academic session 2016-17. The academic session will commence from **15th July, 2016**.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with **50% marks** in aggregate of Physics, Chemistry and Mathematics or Physics, Chemistry, Mathematics and Biology for General & OBC Categories and **40% marks** for SC/ST/Physically handicapped/In service categories.
2. The candidates must have attained 17 years of age on 31st December, 2016.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.


The Government of India has taken the decision to admit the students from **OBC** category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning. As per the conditions stipulated in the Government orders, your State is being allotted **6 (six)** seats, out of which **5 (five)** seats are to be reserved for (**UR+SC+ST**) categories as per reservation policy of the State Government and **1 (one)** seat is to be reserved for candidate belonging to OBC category for admission to B.Tech. (Agril. Engg.) for the academic session 2016-17.

While selecting the candidates against this position, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority recognized by the State Government certifying that candidate does not belong to Creamy Layer will be necessary for the candidate before admission. This may kindly be made known to the candidates well in advance **If the State Government does not find the candidate from OBC category, the OBC seats shall be converted into general category seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **6 (six)** candidates from your state on or before the **12th July, 2016** to the **Dean, College of Agricultural Engineering & Post Harvest Technology, Ranipool, Gangtok-737135, Sikkim** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), 2 (two) passport size photographs duly attested by a gazette officer along with a certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.**

The nominated candidates may please be directed to report to the **Dean, College of Agricultural Engineering & Post Harvest Technology, Ranipool, Gangtok-737135, Sikkim on 15th July, 2016 at 11 a.m.** along with their original documents and admission fee of **₹1470/-** (Rupees one thousand four hundred and seventy) only for admission to the 1st year B.Tech. (Agri. Engg.).
