Sub: Nomination of candidates for admission to 4-year Degree Course of **B.Sc. (Hons.) Forestry** at College of Horticulture & Forestry, Pasighat, Arunachal Pradesh under CAU for the academic session **2018-19**.

Sir,

Nominations are invited from your state for admission to 4-year degree course of **B.Sc. (Hons.) Forestry** for the academic session **2018-19**. The academic session will commence from **6<sup>th</sup> July, 2018**.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of PCB/PCMB/ Inter-Agriculture for General & OBC Categories and **40% marks** for SC/ST/PC/In-service categories.
2. The candidates must have attained **16 years of age on 31<sup>st</sup> August, 2018**.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The Government of India has taken the decision to admit the students from **OBC** category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning. As per the conditions stipulated in the Government orders, your State is being allotted **4 (four)** seats, out of which **3 (three)** seats are to be reserved for **(UR+ST+SC)** categories as per reservation policy of the State Government and **1 (one)** seat is to be reserved for candidates belonging to **OBC** category for admission to **B.Sc. (Hons.) Forestry** course for the academic session **2018-19**.

While selecting the candidates against the **OBC** category, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority **recognized by the State Government** certifying that candidate does not belong to Creamy Layer will be necessary for facilitating admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC category, the OBC seats shall be converted into general category seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **4 (four)** candidates from your state on or before the **3<sup>rd</sup> July, 2018** to the **Dean, College of Horticulture & Forestry, Pasighat-791102, Arunachal Pradesh** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), 2 (two) passport size photographs along with a transparent certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit**.

The nominated candidates may be directed to report to the **Dean, College of Horticulture & Forestry, Pasighat-791102, Arunachal Pradesh on or before 6<sup>th</sup> July, 2018 at 11 a.m.** along with their original documents and admission fee of **₹5580/- (Rupees five thousand five hundred eighty)** only for admission to the 1<sup>st</sup> year **B.Sc. (Hons.) Forestry** course.
