
The nominated candidates must have the following minimum requirements:

2. The candidates must have attained **16 years of age on 31st August, 2018**.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

It is, therefore, requested to send nomination of **02 (two)** candidates from your state on or before the **3rd July, 2018** to the **Dean, College of Horticulture, Bermiok, Sikkim** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), 2 (two) passport size photographs along with a transparent certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit**.

The nominated candidates may be directed to report to the **Dean, College of Horticulture, Bermiok, Sikkim** on or before **6th July, 2018 at 11 a.m.** along with original documents and admission fee of **₹5580/- (Rupees five thousand five hundred eighty)** only for admission to the 1st year B.Sc. (Hons.) Horticulture course.


