2. The candidates must have attained **16 years of age on 31st August, 2018**.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The nominated candidates may please be directed to report to the **Dean, College of Horticulture, Thenzawl, Mizoram on or before 6th July, 2018 at 11 a.m.** along with their original documents and admission fee of **₹5580/- (Rupees five thousand five hundred eighty)** only for admission to the 1st year B.Sc. 
