Sir,

As you are already aware, National Aptitude Test in Architecture (NATA) is being conducted by Council of Architecture at national level since 2006 for admission to First year of 5 year **B.Arch. Degree Course** at all approved institutions all over Country in order to provide a single window Aptitude test to facilitate prospective students across the country to apply for admissions in the course, without having to appear in individual aptitude tests at state level.

In pursuance of MHRD letter no. Secy (HE)/ MHRD/ 2020 dated 18th March 2020 and as per the previous orders issued by Ministry of Home Affairs, Government of India announcing complete lockdown in the country for containment of pandemic Corona Virus (COVID-19), the ensuing First Test and Second Test of NATA 2020 examination for 2020, earlier scheduled on 19th April 2020 and 31st May, 2020 respectively, have been postponed by the Council of Architecture.

The exact dates for the test and revised schedule for important dates for the tests will be announced after assessing the situation in the coming weeks. The Council is hopeful that the country would get back to normal relatively soon; but for now, we are closely monitoring the scenario vis-a-vis the orders and advisories issued by the Government from time to time.


The revised NATA brochure with new dates for the First & Second Tests and other important revised dates shall be uploaded in due course on the website of the Council www.coa.gov.in as well on NATA website www.nata.in.

In view of the above, I request you to kindly bring the above to the notice of the appropriate authorities and all concerned so that they are kept abreast with the latest announcements made by the Council regarding conduct of **NATA 2020**.
