CIRCULAR

Applications are hereby invited from the serving university and college teachers of Govt. Colleges of Arunachal Pradesh having experience of Programme Officer, NSS for a minimum period of 4 (four) years for the post of State Liaison Officer, NSS (in Reader's / Associate Professor's Grade) in the State NSS Cell, Directorate of Higher & Technical Education, Govt. of Arunachal Pradesh, Itanagar. The post will be filled-up on transfer/deputation basis for a period of 2 (two) years which may be extended for a further period of two years based on performance report. The eligibility criteria for selection to the post are as under:

- He / she should have served as Programme Co-ordinator in the University or Programme Officer in a college at least for four years continuously.
- He / she should possess the academic qualification for being appointed as Programme Co-ordinator / Programme Officer as prescribed by the Ministry of Youth Affairs & Sports, Govt. of India.
- He /she should have interest in Youth work in particular and social work in general.
