Tender will be opened on 20 Dec' 2010 at 1500 hrs. in the presence of a board of officers in the office of the Director of Higher & Technical Education, Arunachal Pradesh, Itanagar. Tenderer who intends to be present at the time of opening of the tenders may do so.

Tenders must be accompanied by a Demand Draft of ₹1000/- (Rupees One thousand) only in each case and drawn in favour of the Director of Higher & Tech. Education, Arunachal Pradesh, Itanagar payable at SBI branch, Itanagar as Earnest Money which will be refundable in case of unsuccessful tenderers. The earnest money will be adjusted towards the final payment in case of successful tenderer.

The earnest money of successful tenderer will be retained till the deal is finalized.

The undersigned/government reserves the right to reject any or all tenders without assigning any reason thereof.


