With reference to the subject mentioned above, I am directed to inform you that additional course of 4-Year Degree Programme in Bachelor of Science (Agriculture) under CAU at Barapani, Meghalaya, will be started from the academic session 2015-16. For this session, the classes will be held at the **College of Post-Graduate Studies, Barapani, Meghalaya** to facilitate starting of the course on time.

As such, nominations are invited from your state for admission to 4-year degree course of **B.Sc. (Agri.)** for the academic session 2015-16. The academic session will commence from **1st July, 2015**.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of PCB/PCMB or Agriculture for General & OBC Categories and **40% marks** for SC/ST/Physically handicapped/In service categories.
2. The candidates must have attained 17 years of age on 31st December, 2015.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

It is, therefore, requested to send nomination of **02 (two)** candidates from your state on or before the **27th June, 2015** to the **Dean, College of Post-Graduate Studies, Barapani – 793103, Meghalaya** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), 2 (two) passport size photographs duly attested along with a transparent certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.**

The nominated candidates may be directed to report to the **Dean, College of Post-Graduate Studies, Barapani – 793103, Meghalaya on or before 1st July, 2015 at 11 a.m.** along with their original documents and admission fee of **₹1470/-** (Rupees one thousand four hundred and seventy) only for admission to the 1st year B.Sc. (Agri).
