Nomination of your State Government and duly filled in Application Form may be seat directly to the Institute under intimation to the Director of Technical Education & Training. Government of West Bengal Latest by July 15, 2015 positively. Further to note that as per AICTE's letter no F-42A/97/SPL dated 17.9.99, State Government may also send nominations of few wait listed candidates for filling up the vacant seats, if any, of reserved quota of other states. All such wait listed candidates should also report to the institute by July 21, 2015. While forwarding the applications, respective State Government is requested to ensure that the candidates should conform to the eligibility and other rules and regulations/terms & conditions laid down in the application form/below. Names of the candidates in the forwarding letter should be in the order of merit. Application Form, as enclosed, may be copied at your end as per requirement.

Few important rules and regulations/terms & conditions:

- 1. The candidates must pass Madhyamik or equivalent 10+ exam with mathematics and physical sciences from a recognized Board with 35% provided a State Level Entrance Examination/Common Admission Test are being conducted by your State to select the eligible candidates. In absence of such test, the candidate should have a minimum of 60% marks on Mathematics and Physical Sciences (taken together). They should also be able to communicate/write in English.
- 2. The maximum and minimum age is 21 and 15 years respectively as on 1st January 2015 with 3 years upper age relaxation for SC/ST candidates. Further relaxation for upper age for all may be allowed by the competent authority on request in advance.
- 3. Candidates should be medically fit with normal vision and free from colour blindness. A medical certificate to this effect from the Registered Medical Practitioner is to given in the prescribed format in the application form.
- 4. There is limited hostel accommodation for the male candidates only subject to the vacancy. Male candidates acquiring hostel accommodation should apply separately in the prescribed format to the hostel superintendent immediately after getting admission in the institute. If allowed, they should deposit requisite fees, declaration and abide by the rules and regulations of the hostel failing which their admission/studentship/boardership will be cancelled at the discretion of the Institute/ hostel authority. Name of Local Guardian in Kolkata with detail address, telephone no etc should also be mentioned. Both the guardian and local guardian should be present at the time of admission to endorse their signature.
- 5. Ragging in any form in the institute/Hostel will invite stern action against the persons(s) involved, directly or indirectly, in ragging and it may lead to the cancellation of admission. As per directive of Hon'ble Supreme Court, FIR will also be lodged in the local police station. An Affidavit in prescribed format should be submitted by the candidates and their guardians before admission.
- 6. Candidates are advised to report to the Institute on or before the last date as mentioned above with duly filled in admission form accompanied with attested copied of marksheets/certificates of qualifications, valid age proof, current income certificate in original, ST/SC/OBC/PH certificates, Medical certificated and Affidavit stated above.

Some Important Rules & Regulations (Terms & Conditions) among others

60% Attendance in all classes and 50% pass mark in sessional must for sent up every year. For counting of attendance, absence for any reason including medical ground is not allowed 2. Ragging is strictly prohibited and punishable under the relevant ACT 3. Drinking/Smoking in institute/Hostel is strictly prohibited 4 In case of major electrical fault/strike/other unavoidable reasons food to be arranged by the hostel boarders on their own & they may have to vacate the hostel immediately on instruction by the authority.
