Sub: Nomination of candidates for admission to 5 ½ year Degree Course of B.V.Sc. & A.H. at College of Veterinary Sciences & AH, Jalukie, Nagaland under CAU for the academic session 2019-20.

Sir,

Nominations are invited from your state for admission to 5 ½ year degree course of B.V.Sc. & AH for the academic session 2019-20. The academic session will commence from **16th September, 2019**.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) in all subjects with a minimum of **50% marks** of aggregate in English, Physics, Chemistry and Biology for General & OBC Categories and **40% marks** for SC/ST/Physically challenged/In service categories.
2. The candidates should complete the minimum age of **17 years and the maximum age of 25 years on or before the 31st December, 2019**. There shall be relaxation of maximum age by five years for Schedule Caste or Schedule Tribe or Other Backward Class candidates.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The Government of India has taken the decision to admit the students from OBC category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning. As per the conditions stipulated in the Government orders, your State is being allotted **03(three)** seats, out of which **02 (two)** seats are to be reserved for **(UR+ST+SC)** categories as per reservation policy of the State Government and **1 (one)** seat is to be reserved for candidates belonging to **OBC** category for admission to **B.V.Sc. & A.H.** for the academic session 2019-20.


While selecting the candidates against this position, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority recognized by the State Government certifying that candidate does not belong to Creamy Layer will be necessary for the candidate before admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC category, the OBC seats shall be converted into general category seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **3(three)** candidates from your state **on or before the 11th September, 2019** to the **Dean, College of Veterinary Sciences & AH, Jalukie, Nagaland** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), 2 (two) passport size photographs along with a certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.**

Kindly note that as per guidelines for the Veterinary Council of India, no candidate shall be admitted to the B.V.Sc. & A.H. course unless he/she has been selected/nominated through Competitive Entrance Examination conducted by the concerned State/VCI.

The nominated candidates may please be directed to report to the **Dean, College of Veterinary Sciences & A.H., Jalukie, Nagaland on 16th September, 2019 at 11 a.m.** along with their original documents and annual admission fee of **Rs. 8760/-** (Rupees eight thousand seven hundred sixty) only for admission to the 1st year **B.V.Sc. & A.H.**


