3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The nominated candidates may be directed to report to the Dean, College of Horticulture, Bermiok, Sikkim on or before 1st September, 2020 at 11 a.m. along with original documents and admission fee of Rs. 5580/- (Rupees five thousand five hundred eighty) only for admission to the 1st year B.Sc. (Hons.) Horticulture course.
