The nominated candidates must have the following minimum requirements:

- 1. Passed Higher Secondary (10 + 2) with 50% marks in aggregate of PCM/PCMB for General & OBC Categories and 40% marks for SC/ST/PC/In service categories.
- 2. The candidates must have attained 16 years of age on 31st August, 2020.
- 3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The Government of India has taken the decision to admit the students from OBC category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning.
