Sub: Nomination of candidates for admission to **B.V.Sc. & A.H.** at College of Veterinary Sciences & AH, Selesih, Mizoram under CAU for the academic session 2022-23.

Sir,

Nominations are invited from your state for admission to 5 ½ year degree course of **B.V.Sc. & A. H** for the academic session **2022-23**. The academic session will commence from **1st October, 2022**.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of English, Physics, Chemistry and Biology or Biotechnology for General/OBC/EWS Categories and **47.5% marks** for SC/ST/PwD/In-service categories.
2. The candidates must have completed the minimum age of **17 years** and the maximum age of **25 years on or before 31st December, 2022**. There shall be relaxation of maximum age by 5 years for SC/ST/OBC.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The Government of India has taken the decision to admit the students from OBC category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning. As per the conditions stipulated in the Government orders, your State is being allotted **12 (twelve)** seats, out of which **9 (nine)** seats are to be reserved for **(UR/ST/SC/PwD)** categories as per reservation policy of the State Government and **03 (three)** seats are to be reserved for candidates belonging to OBC category for admission to **B.V.Sc. & A.H.** for the academic session **2022-23**.

While selecting the candidates against this position, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority **recognized by the State Government** certifying that candidate does not belong to Creamy Layer will be necessary for the candidate before admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC category, the OBC seats shall be converted into general category seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **12 (twelve)** candidates from your state on or before the **24th September, 2022** to the **Dean, College of Veterinary Sciences & A.H., Selesih, Aizawl, Mizoram** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), 2 (two) passport size photographs duly attested by a gazette officer along with a certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.**

Kindly note that as per guidelines for the Veterinary Council of India, no candidate shall be admitted to the B.V.Sc. & A.H. course unless he/she has been selected/nominated through Competitive Entrance Examination conducted by the concerned State.

The nominated candidates may be directed to report to the **Dean, College of Veterinary Sciences & A.H., Selesih, Aizawl, Mizoram** on or before **30th September, 2022** along with their original documents and admission fee of **Rs. 8760/- (Rupees eight thousand seven hundred sixty)** only for admission to the 1st year B.Sc. (Hons.) Agriculture course.


