1. Passed Higher Secondary (10+2) with minimum 50% marks in aggregate of PCB/PCMB/Inter-Agriculture for General/OBC (NCL)/EWS Categories and 40% marks for SC/ST/Third Gender/PwBD/In-service categories.
2. The candidates must have attained 16 years of age on 31st August, 2024.
3. The selection/nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.
