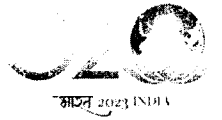


The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10+2) with minimum 50% marks in aggregate of English, Physics, Chemistry and Biology or Biotechnology for General/OBC (NCL)/EWS Categories and 47.5% marks for SC/ST/PwBD/In-service categories.
2. The candidates must have completed the minimum age of 17 years and the maximum age of 25 years on or before 31st December, 2024. There shall be relaxation of maximum age by 5 years for SC/ST/OBC.
3. The selection/nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

Further, I am to inform that exact date for nomination of candidates, admission and commencement of the academic session 2024-25 will be intimated in due course.

***Note: Seats for (UR, ST, SC & other) categories are to be fixed as per the reservation policy of the State Government as done earlier.**




