
The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10+2) with **minimum 50% marks** in aggregate of PCB/PCMB/PCM/Inter-Agriculture for General/OBC (NCL)/EWS Categories and 40% marks for SC/ST/Third Gender/PwBD/In-service categories.
2. The candidates must have attained **16 years of age on 31st August, 2024.**
3. The selection/nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

Further, I am to inform that exact date for nomination of candidates, admission and commencement of the academic session 2024-25 will be intimated in due course.

***Note:** Seats for (UR, ST, SC & other) categories are to be fixed as per the reservation policy of the State Government as done earlier.
