- 1. Passed Higher Secondary (10 + 2) with minimum 50% marks in aggregate of PCB/PCMB/Inter- Agriculture for General/OBC(NCL) Categories and 40% marks for SC/ST/Third Gender/PwBD/In-service categories.
- 2. The candidates must have attained 16 years of age on 31st August, 2024.
- 3. The Sclection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

Further, I am to inform that exact date for nomination of candidates, admission and commencement of the academic session 2024-24 will be intimated in due course.
