Sub: Nomination of candidates for admission to 4-year Degree Course of **B.Sc. (Hons.) Agriculture** at College of Agriculture, Pasighat, Arunachal Pradesh under CAU, Imphal for the academic session 2025-26.

Sir/Madam,

Nominations are invited from your state for admission to 4-year degree course of **B.Sc. (Hons.) Agriculture** at College of Agriculture, Pasighat, Arunachal Pradesh for the academic session 2025-26.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of PCB/PCMB/PCM/Inter-Agriculture for General/OBC(NCL)/EWS Categories and **40% marks** for SC/ST/Third Gender/PwD/In-service categories.
2. The candidates must have attained **16 years of age on 31st August, 2025.**
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

The Government of India has taken the decision to admit the students from OBC(NCL) category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning. As per the conditions stipulated in the Government orders, your State is being allotted **7 (seven)** seats, out of which **5(five)** seats are to be reserved for (UR/ST/SC/PwD) categories as per reservation policy of the State Government and **2 (two)** seats are to be reserved for candidates belonging to **OBC(NCL) category** for admission to **B.Sc. (Hons.) Agriculture** for the academic session 2025-26.

While selecting the candidates against this position, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority recognized by the State Government certifying that candidate does not belong to Creamy Layer will be necessary for facilitating admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC(NCL) category, the seat(s) shall be converted into Unreserved Seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **7 (seven)** candidates from your state on or before the **16th August, 2025** to the Dean, College of Agriculture, Pasighat, Arunachal Pradesh with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), **2 (two)** passport size photographs along with a transparent certificate indicating the date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.

The date for physical reporting by the candidates for admission at the College and commencement of academic session/classes will be intimated in due course.
