महोदय/महोदया/Sir/Madam,

This has reference to the letter No. 1/1/2025/2025-AACCC dated 21.08.2025 received from NCISM, New Delhi on the subject cited above. In this regard, I am pleased to inform you that the North Eastern Institute of Ayurveda and Homoeopathy (NEIAH) Shillong will admit 63 candidates each for BAMS (Bachelor of Ayurvedic Medicine & Surgery) and BHMS (Bachelor of Homoeopathic Medicine & Surgery) programmes for the academic session 2025-26. Out of these, 31 seats in each programme are reserved for the All India Quota, 31 seats for the NE Quota States (Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim & Tripura), and 01 seat for Foreign Nationals.

For the All India Quota seats (31 in each programme), a separate online centralized counselling will be conducted by the Ministry of AYUSH (www.aaccc.gov.in) and the 01 Foreign National seat in each course will be nominated by ICCR.

As per the directives of NCISM & NCH regarding counselling and admission to UG (BAMS/BSMS/BUMS/BHMS/B.Pharm-Ay.) programmes for the academic session 2025-26, **admissions to the State Quota seats are to be carried out through the respective State/UT Counseling Authorities.**

In this regard, I am directed to request to kindly conduct counselling for the reserved BAMS & BHMS course seats under the NE State Quota of NEIAH, Shillong, on merit basis of NEET scores, ensuring that admissions are made as per the quota of the respective state and its reservation policy.

Further, as per the Institute's North East Quota seat distribution roster, **03 seats each in BAMS and BHMS programmes** have been allotted to students from the state of Arunachal Pradesh for the academic session 2025-26.
