Sub: Nomination of candidates for admission to B.V.Sc. & A.H. at College of Veterinary Sciences & AH, Selesih, Mizoram under CAU for the academic session 2025-26.

Sir/Madam,

Nominations are invited from your state for admission to 5 ½ year degree course of B.V.Sc. & A. II at College of Veterinary Sciences & AH, Selesih, Mizoram under CAU for the academic session 2025-26.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum 50% marks in aggregate of English, Physics, Chemistry and Biology or Biotechnology for General/OBC(NCL)(NCL)/EWS Categories and 47.5% marks for SC/ST/PwBD/In-service categories.
2. The candidates must have completed the minimum age of 17 years and the maximum age of 25 years on or before 31st December, 2025. There shall be relaxation of maximum age by 5 years for SC/ST/OBC(NCL)/PwBD.

The Government of India has taken the decision to admit the students from OBC(NCL) category from the Academic Year 2008-09 in all the centrally funded institutions of higher learning. As per the conditions stipulated in the Government orders, your State is being allotted 12 (twelve) seats, out of which 9 (nine) seats are to be reserved for (UR/ST/SC/PwBD) categories as per reservation policy of the State Government and 03 (three) seats are to be reserved for candidates belonging to OBC(NCL) category.

While selecting the candidates against this position, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority recognized by the State Government certifying that candidate does not belong to Creamy Layer will be necessary for the candidate before admission. This may kindly be made known to the candidates well in advance. If the State Government does not find the candidate from OBC(NCL) category, the OBC(NCL) seats shall be converted into general category seats. This may please be kept in mind.

It is, therefore, requested to send nomination of 12 (twelve) candidates from your state on or before the 16th August, 2025 to the Dean, College of Veterinary Sciences & A.H., Selesih, Aizawl, Mizoram with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC(NCL)/Caste/Tribe certificate (if required), 2 (two) passport size photographs duly attested by a gazette officer along with a certificate indicating the date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.

The date for physical reporting by the candidates for admission at the College and commencement of academic session/classes will be intimated in due course.
