Entry level qualification for B.Tech degree program:

The candidates seeking admission to any Discipline of Engineering and Technology should secure minimum of 45% marks for General Category and 40% marks in case of SC/ST Category in 10+2 examination with Physics, Chemistry and mathematics.

However, candidates from non-mathematics background can also apply for B. Tech course in Agricultural Engineering & Technology and Bio-Technology department, and candidates from non-chemistry background can also apply for B. Tech course in CSE/IT/ECE department provided that they satisfy other admission criteria mentioned in the table given below:
