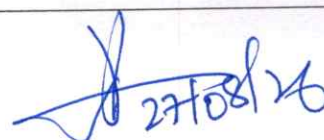
The revised schedule for PCB group counselling will be as under:

First Round of seat allotment	27-08-2026 (Thursday)
Online and Physical Reporting in the respective Directorates	28-08-2026 - 02-09-2026
Second Round of seat allotment	04-09-2026 (Friday)
Online and Physical Reporting in the respective Directorates	05-09-2026 - 08-09-2026
Online Withdrawal of seat (if any)	09-09-2026 (Saturday)
Online Registration for Spot Round (Tentative)	09-09-2026 - 10-09-2026
Date of conduct of Spot Round (if conducted)	11-09-2026 (Friday)

Candidates who have been allotted seat in the 1st Round of allotment but **fails to submit Willingness (Freeze / Float) AND candidates opting for Freeze Option but failing to report to the respective Directorates within 2nd Sept' 2026 (Upto 04:00 PM)** shall be treated as **NOT** interested and the allotment shall stand cancelled automatically. These candidates shall not be eligible to participate in 2nd Round of PCB group counselling.

During physical reporting, candidates are to submit 2 (two) sets of self-attested photocopies of the following (along with the originals) and 3 copies of recent passport size photograph:
