Sir/Madam,

Nominations are invited from your state for admission to 5 ½ year degree course of **B.V.Sc. & A. H** at College of Veterinary Sciences & AH, Selesih, Mizoram under CAU for the academic session 2026-27.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of English, Physics, Chemistry and Biology or Biotechnology for General/OBC(NCL)/EWS Categories and **47.5% marks** for SC/ST/PwBD/In-service categories.
2. The candidates must have completed the minimum age of **17 years** and the maximum age of **25 years on or before 31st December, 2026**. There shall be relaxation of maximum age by 5 years for SC/ST/OBC(NCL)/PwBD.

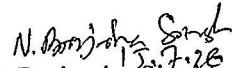
A total of **12 (twelve)** seats is allotted for your state, out of which **9 (nine)** seats are to be reserved for **(UR/ST/SC/PwBD)** categories as per reservation policy of the State Government and **03 (three)** seats are to be reserved for candidates belonging to OBC(NCL) category for admission to B.V.Sc. & AH for the academic session 2026-27.

While selecting the candidates against this position, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority **recognized by the State Government** certifying that candidate does not belong to Creamy Layer will be necessary for the candidate before admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC(NCL) category, the OBC(NCL) seats shall be converted into general category seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **12 (twelve)** candidates from your state on or before the **17th August, 2026** to the **Dean, College of Veterinary Sciences & A.H., Selesih, Aizawl, Mizoram** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC(NCL)/Caste/Tribe certificate (if required), 2 (two) passport size photographs duly attested by a gazette officer along with a certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.**

The date for physical reporting by the candidates for admission at the College and commencement of academic session/classes will be intimated in due course.
