Sub: Nomination of candidates for admission to 4-year Degree Course of **B.Sc. (Hons.) Community Science** at College of Community Science, Tura, Meghalaya under CAU for the academic session 2026-27.

Sir/Madam,

Nominations are invited from your state for admission to 4-year degree course of **B.Sc. (Hons.) Community Science** at College of Community Science, Tura, Meghalaya for the academic session 2026-27.

The nominated candidates **must be females** and should have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of ABC (Agriculture, Biology Chemistry)/Phyic, Chemistry, Agriculture (PCA)/PCB/PCM for General/OBC(NCL)/ EWS Categories and **40% marks** for SC/ST/Third Gender/PwBD/In-service categories.
2. The candidates must have attained **16 years of age on 31st August, 2026**.

A total of **5 (five)** seats is allotted for your state, out of which **4 (four)** seats are to be reserved for **(UR/ST/SC/PwBD)** categories as per reservation policy of the State Government and **1 (one)** seat is to be reserved for candidates belonging to **OBC(NCL)** category for admission to **B.Sc. (Hons.) Community Science** for the academic session 2026-27.

While selecting the candidates against the **OBC(NCL)** category, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority **recognized by the State Government** certifying that candidate does not belong to Creamy Layer will be necessary for facilitating admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC(NCL) category, the seat shall be converted into general category seat.** This may please be kept in mind.

It is, therefore, requested to send nomination of **5 (five)** candidates from your state on or before the **17th August, 2026** to the **Dean, College of Community Science, Sangsanggre, P.O/P.S. Dobasipara, Tura, West Garo Hills, Meghalaya** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe certificate (if required), **2 (two)** passport size photographs along with a transparent certificate indicating the **date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.**

The date for physical reporting by the candidates for admission at the College and commencement of academic session/classes will be intimated in due course.
