Nominations are invited from your state for admission to 4-year degree course of **B.Sc. Ag. (Hons.) Natural Farming** at College of Agriculture, Kyrdekulai, Meghalaya for the **academic session 2026-27**.

The nominated candidates must have the following minimum requirements:

1. Passed Higher Secondary (10 + 2) with minimum **50% marks** in aggregate of ABC (Agriculture, Biology Chemistry)/PCA(Physic, Chemistry, Agriculture)/PCB/PCM/Inter-Agriculture for General/OBC(NCL)/EWS Categories and **40% marks** for SC/ST/Third Gender/PwBD/In-service categories.
2. The candidates must have attained **16 years of age on 31<sup>st</sup> August, 2026**.
3. The Selection/Nomination of candidates should be made through Competitive Entrance Test conducted by the concerned state.

A total of **06 (six)** seats is allotted for your state, out of which **5 (five)** seats are to be reserved for **(UR/ST/SC/PwBD)** categories as per reservation policy of the State Government and **1 (one)** seat is to be reserved for candidates belonging to OBC(NCL) category for admission to **B.Sc. Ag. (Hons.) Natural Farming** for the academic session 2026-27.

While selecting the candidates against the OBC(NCL) category, you must ensure that the candidate does not belong to Creamy Layer as specified by the Government of India and certificate to that effect from the competent authority **recognized by the State Government** certifying that candidate does not belong to Creamy Layer will be necessary for facilitating admission. This may kindly be made known to the candidates well in advance. **If the State Government does not find the candidate from OBC(NCL) category, the seat shall be converted into Unreserved Seats.** This may please be kept in mind.

It is, therefore, requested to send nomination of **06 (six)** candidates from your state on or before the **17th August, 2026** to the concerned **Dean, College of Agriculture, Kyrdekulai-793105, Ri-Bhoi, Meghalaya** with a copy to the undersigned. The list of nominated candidates should be sent along with the complete bio-data, attested copies of mark sheets, age proof certificate, domicile certificate, OBC(NCL)/Caste/Tribe certificate (if required), 2 (two) passport size photographs along with a transparent certificate indicating the date of holding Entrance Test, rank of student in the Entrance Test and criteria adopted for determination of merit.

The date for physical reporting by the candidates for admission at the College and commencement of academic session/classes will be intimated in due course.
