CIRCULAR

This is for general information of all concerned that the **SPOT** round Counselling will be conducted on **11th Sept' 2026 from 1030 Hrs. onwards at the Auditorium Hall of the Dorjee Khandu State Convention Centre, near the IG Park, Itanagar** for allotment of the vacant seats after 2nd round of Seat allotment and withdrawal of seats.

The following candidates will be eligible to participate in the **SPOT** Round:

1. Candidates who have opted for Freeze option and reported to the respective Directorate but have withdrawn their allotted seat ONLINE within the stipulated time i.e. **9th Sept' 2026**.
2. Registered candidates who have **NOT** been allotted any seat up to second round.
3. Fresh candidates who could not register before the first round but wants to participate now. They will have to register Online through www.apdhte.nic.in / apjee.co.in and pay the necessary registration fee. The portal for registration will be live from **1000 hrs of 9th Sept' 2026 to 1500 Hrs of 10th Sept' 2026**.
4. Candidates who haven't opted for Freeze Option after the 2nd Round of allotment will be automatically eligible to participate.
5. Candidate who have opted for Freeze option but hasn't reported to the respective Directorate will be considered as surrendered and they can participate in the Spot Round.
6. All Candidates willing to participate in the Spot Round shall have to invariably deposit Seat Acceptance Fee/ Security Deposit of **Rs. 5000/-** through the portal apjee.co.in. on or before 4 pm of 10th Sept' 2026. Candidates who have already paid the seat acceptance fee of Rs. 5000/- need not have to pay again. Candidates who have paid the Seat acceptance fee of Rs. 3000/- shall have to pay the remaining fee of **Rs. 2000/-**.
7. Candidates who have not paid the Security Deposit / Seat Acceptance fee within 3 pm of 10th Sept' 2026 **SHALL NOT** be eligible for participation in the Spot Round counselling.

The allotment will be done on the basis of the merit of the registered candidates as per All India Rank of NEET 2026.

Candidates are advised to bring all their Original documents as mentioned in the Information Brochure and be prepared to move immediately for admission in the allotted institution.

The details of vacancies will be published in the official Website at **1200 Hrs of 10-09-2026** and the merit list of candidates eligible for Spot round will be published at **1800 Hrs of 10th Sept' 2026**.
