**BOND CUM AGREEMENT**

*(To be sworn non judicial stamp paper)*

*(For **FINANCE ASISTANCE** for pursuing higher studies in abroad foreign Universities from the Government of Arunachal Pradesh).*

KNOW ALL MEN BY THESE PRESENT THAT WE;

Mr./Miss \_\_\_\_\_ Son/Daughter of \_\_\_\_\_ of the District of \_\_\_\_\_ in the state of Arunachal Pradesh hereinafter called **“THE STUDENT”**: which expression shall unless repugnant to the context means and include his/her **heirs, administrators and assigns,**

AND

Mr./Mrs/Miss \_\_\_\_\_ Son/Daughter of \_\_\_\_\_ of the District of \_\_\_\_\_ in the state of Arunachal Pradesh hereinafter called **“FATHER/MOTHER/NATURAL GUARDIAN”** of the Student which expression shall unless repugnant to the context mean and include his/her **heirs, administrators and assigns,**

AND

**FURTHER, WHEREAS** the Government has decided to prescribe a condition for admission to the Course of Higher Studies in **ABROAD/FORIEGN COUNTRIES**, (hereafter referred to as **THE SAID COURSE**) that **STUDENT SO ADMITTED** shall complete the said course from the \_\_\_\_\_ (Name of the

Institute/University) to which He/She is admitted, and that He/She shall complete the course opted within stipulated period required to the said course in the\_\_\_\_\_College/University,(herein referred to as “**THE SAID COLLEGE**”).

NOW THIS BOND OF SURETY WITNESS and hereby BINDETH the Student to:

- 1). Be fully responsible and liable for the correctness and genuineness of the School (Including Higher Secondary and equivalent) certificates and mark sheets submitted by him/her to the Government in support of his/her candidature for extending financial assistance for higher study in Abroad, and
- 2). Diligently prosecute and complete the said course at the said College, and NOW THIS BOND is executed with the condition that if the student fully discharge the above mentioned terms and condition, then this Bond cum Agreement shall be void and ineffective from the date on which he/she completes 5 (Years) of service in the rural areas, otherwise this Bond cum Agreement shall continue to remain effective and in full force until fully discharged by the student.

**IN THE EVENT** of student committing a breach of any of the terms and conditions set out in this **Bond cum Agreement**, or its being subsequently discovered or detected that the School (Including Higher Secondary and equivalent) certificates and marks sheets submitted by him/her to the Government in support of his/her candidature for nomination to the said course being incorrect, fabricated, forged or otherwise, or unable to complete the course opted within a stipulated academic time period the whole of the bonded that that whole amount of scholarship/Financial assistance extended by the Government of Arunachal Pradesh shall become jointly and severally payable by the students, his/her **Father/Mother/Legal Guardian** along with interest of the amount extended and the **SURETY** forthwith, besides such other civil and criminal action that may be taken against the student, his/her **Father/Mother/Legal Guardian and the surety** according to law of the Government may without prejudice to any other rights and remedies available to the Government, recover the whole amount from the student, his/her Father/Mother/Legal Guardian and the surety.

**AND UPON MAKING OF SUCH** payment, the obligation created by this Bond cum Agreement shall be void and of no effect, otherwise it shall remain in full force till discharged in full.

PROVIDED ALWAYS and IT IS HEREBY SPECIFICALLY AGREED and **DECLARED** that the decision of the Government of Arunachal Pradesh, as to whether the student has not performed or observed any of the obligation, terms and condition herein before set out and recited shall be final and binding on the parties hereto.

PROVIDE FURTHER that the liability of the student, his/her Father/Mother/Legal Guardian and the surety hereunder shall not be impaired or discharged by reason of time being granted or may forbearance, act or omission of the Government with or without the knowledge or consent of the student, his/her Father/Mother/Legal Guardian and the surety in respect of performed or discharged by the student nor shall it be necessary for the Government to sue the Student or his/her Father/Mother/Legal Guardian and the surety for the **FULL AMOUNT** due hereunder.

Provided further that this **Bond cum Agreement** shall in all respects by Governed by the laws of India.
