**GUIDELINES FOR GRANT OF FINANCIAL ASSISTANCE TO THE STUDENTS  
UNDER THE SCHEME "GOLDEN JUBILEE MERIT AWARD"**

The Government of Arunachal Pradesh, Department of Higher and Technical Education have been providing recognition to a sum of **Rs 2.00 Lakh (Rupees Two Lakh)** only as '**Golden Jubilee Merit Award**' to any APST students or any students completing Class XII Board Examination from Schools of Arunachal Pradesh on qualifying National Level Entrance Examinations and securing admission to IITs, IIMs, AIIMs and NLUs. The Directorate of Higher & Technical Education under Department of Education has been implementing the scheme with the approval of State Cabinet vide No. CAB/M-02/01/2022/611 dated 27<sup>th</sup> January, 2022 and Notification vide No. THE-17/2/2022-THE-BR-THE/4918-30 dated 11<sup>th</sup> March,2022.

The following guidelines/norms will be followed for considering financial assistance to any APST students or any students completing Class XII Board Examination from Schools of Arunachal Pradesh on qualifying National Level Entrance Examinations and securing admission to IITs, IIMs, AIIMs and NLUs, is follows:

- 1. Short Title:-** This scheme may be called recognition of Financial Assistance to the any APST students or any students completing Class XII Board Examination from Schools of Arunachal Pradesh on qualifying National Level Entrance Examinations and securing admission to IITs, IIMs, AIIMs and NLUs.
- 2. Applicability:-** This scheme will be applicable to the any APST students or any students completing Class XII Board Examination from Schools of Arunachal Pradesh on qualifying National Level Entrance Examinations and securing admission to IITs, IIMs, AIIMs and NLUs.
- 3. Objective of the Scheme:-** The Govt. of Arunachal Pradesh desires to encourage APST students or any students passing Class XII from schools located within the State for selection to IITs, IIMs, AIIMs and NLUs through National Level Entrance Examinations and admission thereof.
- 4. Commencement:-** The guidelines/norms shall be effective from the academic session 2021-22.
- 5. Terms and conditions of the scheme:-**
  - a. The bonafide APST students of Arunachal Pradesh shall be eligible for applying for Financial Assistance.

- b. The APST students who have passed class XII from any schools/Higher education institutions across the country or abroad; cleared National Entrance Examinations; selected and admitted; shall be eligible for the scheme, and;
  - c. Apart from APST students, any Students who have passed Class XII from the any schools/Higher education institutions located within the State of Arunachal Pradesh; cleared National Entrance Examinations; selected and admitted; shall be eligible for the scheme.
  - d. The eligible applicant shall submit duly filled in **application form** collected from the office of the Directorate of Higher & Technical Education or download from the official **website:apdhte.nic.in** of the Directorate within the prescribed time with requisite documents.
  - e. **The financial assistance amount shall be transferred to the student's concerned bank account through Treasury/DBT mode as and when fund is made available.**
  - f. The application must be accompanied with self attested copies of (i) passport size photographs (ii) Scheduled Tribe Certificate issued by the competent authority (if applicable), (iii) admission receipt, (iv) Result (v) Identity Card issued by the Institutions, (v)Academic certificates and such other relevant documents whichever is required.
  - g. The candidates already in Govt. service shall not be entitled to the financial assistance.
  - h. Incomplete applications shall be summarily rejected.
  - i. Only one time Financial Assistance shall be extended / granted to the student.
  - j. Any application or proposal which is not in conformity with this guideline shall not be considered or processed in DHTE office.
  - k. **If any student obtains the financial benefits by indulging in fraudulent means he/she shall be liable for action as per the provision of Indian / State Laws.**
  - l. Extending of financial assistance is subject to the availability of fund with the State Govt.
6. The Department reserves the right to cancel/withdraw any such financial assistance already granted to a candidate under the scheme.
